Matters arising:

War Memorial no further update

A14 junction email Stephen Greenhill has been on sick leave and asking for time to deal with his work.

AWA Pumping Station entrance Mr Baker reported Mr Burton (Green Acres) had cleared away the rubble .

Goosey Close Playing Field repair of climbing frame – Mr Burton reported this has been completed by Fenland Leisure Ltd

Public Space Protection Order control of dogs — any further relevant information had been passed on to the Community Protection & Enforcement Team by Mr Thomason and others. The clerk had enquired the current status of the investigation and had been advised this is continuing but is expected to take several months.

Transparency Funding no notification from CAPALC at this time

Tree Surveys & Remedial Work Global Tree Solutions Ltd Goosey Close Playing Field - the Ash tree has been pollarded and left in safe condition. When the invoice is received Easton United Charities to contribute half cost.

St Peter's Churchyard - work has been carried out to three trees for the Parochial Church Council and left in safe state. The Parish Council had agreed to pay half the cost of the work. Mr Baker to advise Brian Davis and the PCC.

Church Road/Stonely Road signpost - Mr Baker has ordered from London Road Signs. He also reported Charles Nixon had offered to repaint the black lettering on the local village signs and he has also to contact the owner of the property in Grange Croft to clear the overgrown hedging obscuring the sign at the junction of Church and Stonely Roads.
