Byways & Footpaths: Mr Thomason reported Hartham Street is again extremely badly rutted and almost impassable. He had reported this to CCC again.

Footpath to Spaldwick 209/13: reported to CCC again as path still unmarked

Bus Shelter: Charles Nixon is to carry out this work

Defibrillator: ordered and delivered. The clerk had taken it to Alasdair Graham to arrange installation and training. The insurance company to be advised of addition to policy.

**Playing Field** – **Goosey Close** - Wicksteed Leisure Ltd had carried out the unaccompanied inspection of the equipment. The report received advised that the overall condition as generally satisfactory. Comments on the report noted: additional information be provided to the sign on the gate, field although fenced would not stop animals from getting into the field and also recommended a survey of the trees around the edge of the field. The Parish Council had already had a tree survey carried out 2016

Mr Burton said he would check the condition of the rail on the climbing frame and the hedge around the field required trimming. He quoted £30 for this.

**Village Roads:** reports had been received that HGVs are missing the turn into RD Williams Ltd for their overnight parking resulting in having to try to turn around when the village roads are completely unsuitable. The clerk offered to speak to RD Williams to suggest better signage.
