2025-26/114 footpaths, roads, BOATS & verge obstructions
A response at last received from the Enforcement Officer, George Hay. The premises in Easton and Stonely Roads which have been the subject of and had not complied with enforcement notices would be revisited. A map showing the boundaries in Stonely Road would be forwarded.
- A water leak in Church Road in front of Townsend Cottage has been reported to AWA. AWA say this has been checked, is a private leak, and the property owners advised
- 2025-26/114 Chapel Lane-The Lane area clearance An eventual reply from the Green Infrastructure Team/Tree Officer advised no non essential expense is being considered by CCC. Mrs Bell reported the builders currently using the area for parking had offered to relevel the ground when nearby building works completed. It was requested she ask them to contact Steve Thomason to arrange this.
