### 2025 - 2026

- 144 Apologies for absence: received from Clive Wood, Mr Thomason gave apologies for expected late arrival from Mr Baker. In the absence of Mr Baker the Chair was taken by Steve Thomason
- 145 Declaration of financial or personal interest:  
to receive members' declarations as to personal and/or prejudicial interests and the nature of those interests in relation to any agenda item. None declared
- 146 The Minutes of Meeting 8<sup>th</sup> January 2026 circulated for consideration were approved without comment and signed by Steve Thomason
- 147 Matters arising
- 2025-26/136 footpaths, roads, BOATS & verge obstructions. The Enforcement Officer had provided a map showing the highway line in Stonely Road and confirmed the removal of any obstructions had not been dropped. The owners of the properties would be recontacted at the beginning of March with requests to remove the obstructions.
- 2025-26/136 Chapel Lane-The Lane area clearance. Mr Thomason has received an assurance from the builders working at premises in The Lane that their remedial work would be carried out in due course.
- 2025-26/136 A14 junction Mr Wood had asked that as a villager had contacted him about improving the markings in the central reservation. This has previously been discussed with Alan Trille (Area Manager, National Highways) who had said that markings are standard.
